Approval of Check Warrant #2223-005

Mr. Finello gave an overview of activities and events that took place at the school. For the month of December, the students have been “taking a trip around the world” visiting countries such as Sweden, Italy, Germany and Mexico. Mr. Thofte, a parent, came to the school to teach the children about Swedish holiday traditions. In the K/1 academics, the students are continuing their lesson on the five senses, counting and writing 11-19, and double-digit facts. The 2nd grade students will be completing their unit reader, Bedtime Tales and learning about 2-digit addition and subtraction with and without regrouping. In music and art, the children have been practiced their holiday songs with Ms. Abby and painted winter scenery with Mrs. Doyle. In technology class,

Our students wrote pen pal letters to introduce themselves to some of the Wainscott School children. On December 2nd, we had the opportunity to meet them in-person and enjoy a pizza lunch at their school. We look forward to collaborating with the Wainscott School for the remainder of the school year.

Ms. Oppenheimer hosted a snowflake ornament craft and afterwards we displayed them on a tree outside as the back drop for the winter concert. Fun was had by all!

Mrs. Hatgistavrou donated gingerbread houses to the school and participated in decorating them with the students on December 15th. Mr. Schultz, will be reading "How the Grinch Stole Christmas" on December 22nd during the holiday party. The children visited the East Hampton YMCA for their first swim lesson at the beginning of the month. They will continue these lessons in January along with ice skating at Buckskill Winter Club.

School tours are now taking place for interested families that reside in and out of district for the 2023-2024 school year. The Board discussed the enrollment and will revisit the out-of-district student tuition rate at a future meeting.
